At the time of this inspection 2 non-kitchen staff members were observed reaching inside the ice machine and collecting ice without previously washing their hands. Only kitchen personnel shall access the food contact surfaces.

CODE REFERENCE: 64E-11.003(3). Employees must use proper handwashing techniques and wash hands at appropriate times and places.

Violation #55. Facilities installed, maintained, & clean

At the time of this inspection staff bathroom was observed without any source of ventilation. Window in the bathroom was observed locked shut. Provide natural or mechanical ventilation to the staff bathroom.

CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.
